Terms and Conditions

1. Introduction

Welcome to Clancy of the Overflow ("Company," "we," "us," or "our"). These Terms and Conditions ("Terms") govern your purchase, access to, and use of our products and services, including but not limited to the Pure Sine Wave Power Inverter ("Product"), and any related services provided by us. By purchasing or using our Product, you agree to be bound by these Terms.

2. Definitions

- **"Product"** refers to the Pure Sine Wave Power Inverter and any accessories, components, or related materials sold or provided by the Company.
- "Customer," "you," or "your" refers to the individual or entity purchasing or using the Product.
- "Website" refers to our official website and any subdomains.
- "Services" refers to any services provided by the Company, including customer support and technical assistance.
- "Third-Party Services" refers to any services provided by third parties that may be integrated with or used in conjunction with our Product.

3. Acceptance of Terms

By accessing, purchasing, or using our Product or Services, you acknowledge that you have read, understood, and agree to be bound by these Terms, as well as any additional terms, conditions, or policies referenced herein or available by hyperlink.

4. Eligibility

6.2 Order Acceptance and Cancellation

- **Order Confirmation:** All orders are subject to acceptance by us. Upon receiving your order, we will send you a confirmation email with order details.
- **Right to Refuse:** We reserve the right to refuse or cancel any order for any reason, including but not limited to:
 - Product unavailability.
 - Errors in pricing or product descriptions.
 - o Suspected fraud or unauthorised transactions.
- **Cancellation:** If we cancel your order, we will notify you and refund any amounts paid.

6.3 Shipping and Delivery
