Welcome to FSP

Thank you for joining FOREX Signal Pro

Our Signal provider service is aimed at helping you gain financial independence as well as assist you in becoming a profitable trader. We give you the opportunity to earn via Free Signal packages. All new members receive \$30 to trade with if they are first time XM members. You are required to make a minimum deposit of \$100 when starting to trade. This is deposited directly into your XM broker account which only you have access to, this allows you to have a reasonable amount of funds to trade with. Upon completing registration you need to provide admin with your full name and surname, mt4 / Mt5 ID and cell number. Thereafter once payment has been confirmed you will be sent the telegram link to the signal group.

Due to the poppy act we will not have access or control of this trading account. It is important that you use the referral link as this also allows us to get exclusive offers from XM for members as well as make it easy on our part to provide assistance as we can liaise directly with XM to resolve any disputes

Forex Signal Pro started as an exclusive service spread by word of mouth. However we decided to open our services up to the public as to grant ordinary people access to premium opportunities, we do not post online due to the nature of scammers. You can find us on Facebook.

If you are new to trading get comfortable first. Start with 0.10 lots on your first day and gradually increase it by 0.20, 0.30, 0.40, 0.50 lots for the day. Please keep record of the trades you are entering and how much they cost at 0.10 lots so that u have a documented estimation to refer to. Eg. Gold 0.10 lots = R5. **Pay attention to balance and Margin.** Once you understand how this works you may proceed to using up to 10% of your balance to trade with. A simple percentage calculator app should make this process very easy so that you do not exceed your maximum margin of 10%: [Percentage Calculator](#)

The market is a double edged sword, If you trade with \$100 the market can move in your favor by \$100 or against you by \$100. So trade responsibly.

To put it simply if 10 apples represented a \$1 000 balance. if you trade 1 apple (representing 10% margin or \$100) the market moves for or against you by 1 apple (\$100), similarly if you had 3 apples the market could move against you by 3 apples (\$300). So the more apples you have invested in the market the greater the potential profits but also the potential risk. Bare in mind everything is priced differently. Please trade responsibly.

You won't stand a good chance to make real money in trading up until your margins is \$1 000. which means you can potentially make a \$100 per trade. Which is why the recommended amount is \$1 000 as this gives you up to a 70% deposit bonus. Which would bring your total tradable funds up to \$1 730.

How to get started

If you want to Receive signals you will need to

1. Register XM account
2. Provide Proof of funded account
3. Download meta trader
4. Join via Telegram link
5. Read FSP rules
6. Read Disclaimer

Please Note:

When registering please ensure you have a standard account.

If you are already with XM, you need to log in first and then click the link provided.

Signals are sent via telegram, Once you have joined an FSP group or channel please go to telegram settings and enable "group" notifications. Change the Alert to something that will get your attention. All we ask is that you commit to trading 1 signal a day as a minimum standard so that you can receive the full benefit of our services and truly test us based on consistency.

If you are new to trading please check out the beginners tutorial section once you are added to a FSP Novice and go through all beginner content videos as to clearly understand how to open a trade, close a trade, set a buy stop, take profit and stop loss. practice doing this on a demo account after going through the beginners content

STEP 1:

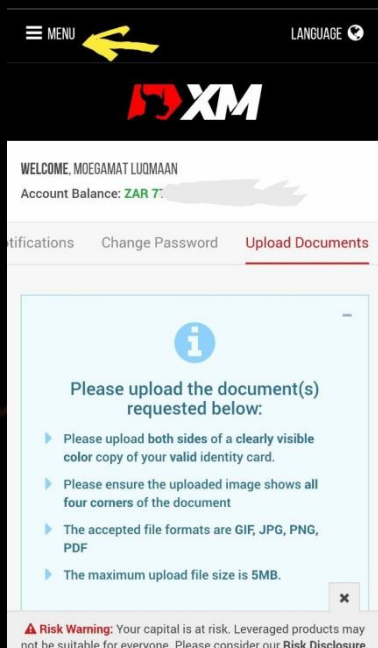

- Please upload ID (not drivers license)
- For proof of residence upload a Bank statement or alternatively a utility bill
- Please ensure that all wording is clear and all corners of the document is easily visible

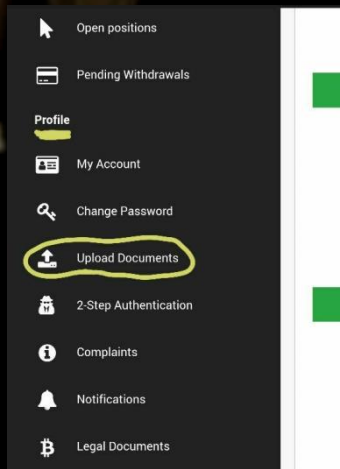
Step 2:

Scroll all the way down until you get to profile and select upload documents

Upload Documents

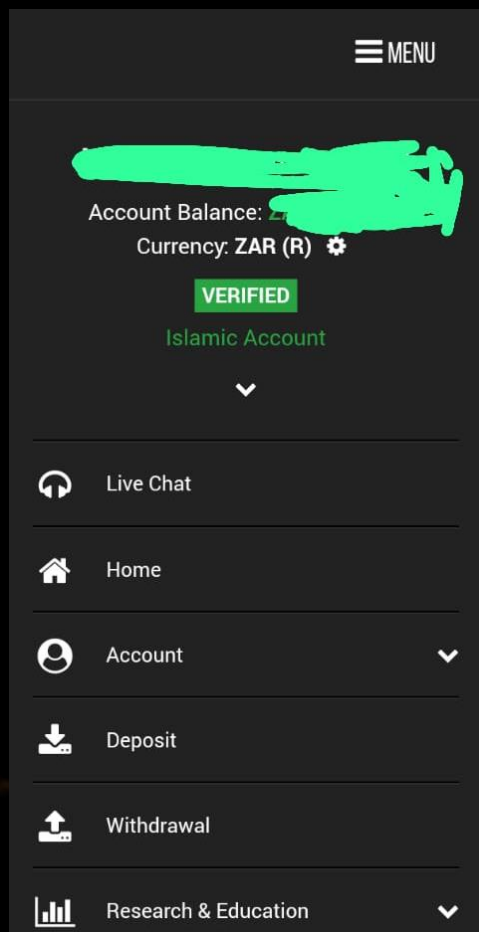
Once you have uploaded your documents, check email for confirmation that verification has been completed. Your meta trader login and server will also be in your email. When this is complete, bonuses can be claimed under the "My Bonuses" section upon logging back into XM

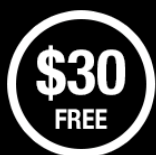

Provide this information to an Admin.

Rule 4: Trading news is optional and can lead to greater profits/risk as this is 50/50 since no one can be certain what the outcome will be and news moves instantly. The best we can do is do an assessment. If however you are going to be trading news please ensure you transfer 80% of all funds over to reserve acc before trading news.

Rule 5: For your own safety, no re-entries on closed trades is allowed. Wait for the next signal to be released instead.
